# 80<sup>th</sup> Anniversary Branch Sweepstakes Rules

# 1. Sweepstakes Administration

This sweepstakes is being administered and operated by Unitus Community Credit Union (Unitus).

#### 2. How to enter

Participants may enter the sweepstakes by way of filling out a raffle slip in a Unitus branch. Limit one entry per person. No purchase necessary to enter. One winner will be randomly selected from each Unitus branch location and the \$80 cash prize must be picked up at the branch or deposited into a Unitus account.

#### 3. Sweepstakes Period

The Sweepstakes period runs from 11:00 a.m. and 2:00 p.m. on July 24, 2017. The winning entry from each Unitus branch will be drawn on July 24, 2017. Winners will be notified by phone or email. In the event we are unable to contact the winner, Unitus CCU will choose an alternate winner five (5) business days after the applicable Drawing Date.

# 4. Eligibility

The prize will be awarded by random drawing of all eligible entries. Odds of winning depend on the number of entries received. To be eligible for this drawing you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older. Void where prohibited by law. Employees of Unitus CCU and their immediate family members are not eligible to participate. All decisions are final and are at Unitus CCU's sole discretion.

#### 5. Prizes

The prize will be awarded by random drawing of all eligible entries. You do not need to be a Unitus member in order to be deemed eligible.
