

## **'Share Your Before | After' Social Media Contest Sweepstakes Rules**

### **1. Sweepstakes Administration**

This sweepstakes is being administered and operated by Unitus Community Credit Union (Unitus).

### **2. How to enter**

Participants may enter the sweepstakes by tagging Unitus on their Facebook or Instagram posts sharing their 'before' and 'after' home repair photos. Entries will also be accepted on unitusccu.com by completing the online form. Limit one entry per person. No purchase necessary to enter. One winner will be randomly selected from posts across all platforms on July 29, 2019.

### **3. Sweepstakes Period**

The Sweepstakes period runs from 8:00 p.m. on July 21, 2019 to 11:59 p.m. on July 28, 2019. The winning entry will be drawn on July 29, 2019. Winner will be notified on the appropriate platform (Facebook or Instagram), or contacted via information submitted in online form (phone or email). In the event we are unable to contact the winner, Unitus CCU will choose an alternate winner one (1) business day after the applicable Drawing Date.

### **4. Eligibility**

The prize will be awarded by random drawing of all eligible entries. Odds of winning depend on the number of entries received. To be eligible for this drawing you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older. Void where prohibited by law. Employees of Unitus CCU and their immediate family members are not eligible to participate. All decisions are final and are at Unitus CCU's sole discretion.

### **5. Prizes**

Winner will receive a \$100 Visa gift card to further their home repair needs. The prize will be awarded by random drawing of all eligible entries. You do not need to be a Unitus member in order to be deemed eligible.

The prize that may be awarded to the eligible winner is not transferable or exchangeable for any other prize. If a winner cannot be contacted or is disqualified for any reason, Unitus reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

All decisions are final and binding. Unitus shall not be responsible for late, lost, misdirected, or unsuccessful efforts to notify winner.

### **6. General Conditions**

Federal, state and local tax liability and any other expenses are the sole responsibility of prizewinner. Void where restricted and prohibited.

Any valuation of the prize stated above is based on available information provided to Unitus, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winner is solely responsible for reporting and paying any and all applicable taxes related to the prize. Winner must provide a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Company will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.
