

# **Bridgeport Village Grand Opening Sweepstakes Rules**

## 1. Sweepstakes Administration

This sweepstakes is being administered and operated by Unitus Community Credit Union (Unitus).

### 2. How to enter

No purchase is necessary to enter. Receive up to four (4) entry tickets at the Bridgeport Village branch of Unitus at the Grand Opening event and be automatically eligible for the sweepstakes drawing for one of four prizes: \$500 cash (1), an iPhone 14 (1), a Sony PlayStation 5 (1), or a trip giveaway consisting of a \$1,000 Alaska Airlines gift certificate, a \$1,000 Airbnb gift card, and a \$500 Unitus Visa gift card (1). To enter without earning an automatic entry, email your name, address, and phone number to <a href="marketing@unitusccu.com">marketing@unitusccu.com</a> no later than 5:45 p.m. on January 20, 2023 – email entries will be placed in the \$500 cash prize drawing only. Odds of winning depend on the number of entries received.

Receive one (1) entry for attending the Grand Opening event. Receive one (1) entry if a current Unitus member. Receive one (1) entry if following Unitus on one or more social media channels. Receive one (1) entry if a Go Savings, Money Market, or Certificate of Deposit is opened between January 3 and January 20, 2023. Up to four (4) entries are allowed per person. Entries are placed in any of the four (4) prize bucket as selected by the person entering the drawing(s). Unitus shall not be responsible for lost, misdirected, incomplete, or illegible entries.

#### 3. Sweepstakes Period

The Sweepstakes period runs between 4:00 p.m. and 6:00 p.m. on January 20, 2023 unless entered via email (see above). The winners will be drawn at the Bridgeport Village Grand Opening event at 6:00 p.m. on January 20<sup>th</sup> and all winners must be present to win unless entering via email. Limit one prize per winner.

#### 4. Eligibility

To be eligible for the Sweepstakes you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older to win. Parents may claim prizes on a minor's behalf, expect for \$2,500 Vacation Package. Limit of up to four entries per person. Void where prohibited by law. Employees of Unitus Community Credit Union and members of their immediate family are not eligible to win.

#### 5. Prizes

Unitus will select four (4) prize winners. The prize winners will be randomly selected from all eligible entries in each of the four drawings. One drawing for each of the four (4) prizes that may be awarded to the eligible winners are \$500 cash (1), an iPhone 14 (1), a Sony PlayStation 5 (1), or a trip giveaway consisting of a \$1,000 Alaska Airlines gift certificate, a \$1,000 Airbnb gift card, and a \$500 Unitus Visa gift card (1).

The prizes that may be awarded to the eligible winners are not transferable nor exchangeable for any other prize. If a winner cannot be contacted or is disqualified for any reason, Unitus reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

The odds of being the prize winners depend on the total number of eligible entries received. If any selected winning entry is disqualified for any reason allowed under these rules, Unitus will select another winner. All decisions are final and binding. Unitus shall not be responsible for late, lost, misdirected, or unsuccessful efforts to notify winners.

#### 6. General Conditions

Federal, state, and local tax liability and any other expenses are the sole responsibility of prizewinners. Void where restricted and prohibited.

Any valuation of the prize stated above is based on available information provided to Unitus, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winner is solely responsible for reporting and paying all applicable taxes related to the prize. Winner must provide a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Company will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS. The iPhone 14 is valued at \$899 and the Sony PlayStation is valued at \$560 (other prizes are \$500 cash and \$2,500 in trip giveaways).

## 7. Consent to Publicity and Release

By accepting the prize, winner consents to the use of his/her name and likeness for publicity purposes without further compensation, unless prohibited by law. All entrants agree to release and hold harmless Unitus and their immediate family from all claims of any kind arising directly or indirectly from the Sweepstakes, from any Sweepstakes prize, or from any publicity about the Sweepstakes.

## 8. Miscellaneous

By entering the Sweepstakes, you agree to comply with all terms and conditions mentioned herein. Noncompliance with any entry procedure will result in disqualification.
